On March 18th more than 800 adult learners and educators from across the state gathered at the State House for Adult Literacy Awareness Day. This annual event, organized by the Massachusetts Alliance for Adult Literacy (MassAAL) and the Massachusetts Coalition for Adult Education (MCAE), draws participants in General Educational Development (GED), Adult Basic Education (ABE), and English for Speakers of Other Languages (ESOL) classes to tell their stories and urge their local representatives to continue support for these programs.
